- ✓ Must be a “Brick & Mortar” business
- ✓ Must be located in Sedgwick County
- ✓ Can receive assistance only once during the December to March Pay It Forward “Season”
- ✓ A Limited number of Large and Small Businesses can be awarded each “Season”
(3 large and 10 small businesses, for each of the three drawings. In the event that 3 businesses have not applied, two small businesses will be able to take the place of each large business.)
- ✓ County Property taxes must be paid to current year
- ✓ Application must be filled out completely and submitted with prize
- ✓ Small businesses of 1-6 Employees must provide a desirable prize worth a minimum of \$75
- ✓ Large Businesses of 7 – more employees must provide a desirable prize worth \$150
